# Terms and Conditions of Use for BHTOM.space

#### 1. Introduction

Welcome to BHTOM.space ("BHTOM," "we," "our," or "us"). These Terms and Conditions govern your use of the BHTOM tool, a platform designed for astronomers, researchers, educators, and the space industry.

## 2. Data Upload and Ownership

- 2.1. Users may upload images from telescopes, provided they are calibrated on a best-effort basis (bias, dark, flat-field corrections applied).
- 2.2. The original uploaded data remains the property of the user who uploaded them.
- 2.3. BHTOM reserves the right to generate higher-level data products extracted from the original uploaded data. The higher-level data remains the property of BHTOM.

## 3. Target Management and Public Data Visibility

- 3.1. When adding a public target to our system, you agree that the target name and its coordinates will be visible to other registered users.
- 3.2. When adding a non-public object to our system, you agree that the target name and its coordinates will be visible to the BHTOM administrators.

## 4. Data Access and Downloading

- 4.1. All registered users may download the products provided by BHTOM if available.
- 4.2. We track and log information regarding data downloads, including which targets were downloaded, by whom, when, and from which IP address.
- 4.3. Users agree that BHTOM may store user information, including affiliations, but will not share this information with third parties.

### 5. Communication and Notifications

5.1. By using BHTOM, you agree that we may use your registered email address to send occasional notifications regarding observing campaigns, regular newsletters and other service-related updates.

## 6. Data Usage in Scientific Publications

- 6.1. Users who download data and use it in scientific publications must contact BHTOM operators to agree on the authorship.
- 6.2. When using BHTOM-generated products in publications, users agree to include BHTOM builders as co-authors. The current list of BHTOM builders can be found in the About section of the BHTOM.space webpage or after contacting BHTOM.

6.3. We may also be required to include all observers and their colleagues (e.g., data analysts, sponsors, telescope operators, observing time owners) as co-authors.

#### 7. General Terms

- 7.1. BHTOM reserves the right to modify these Terms and Conditions at any time. Users will be notified of significant changes.
- 7.2. By using BHTOM, you confirm that you have read, understood, and agreed to these Terms and Conditions.
